7:15 Celebrating Our Accomplishments

Nanci Champlin, Executive Director

- Successful Mayoral Mixer: thank Dave, Kat, Sarah, Nancy and Daniel
 - o Attendance was at maximum capacity, hosted at Laurelhurst Club
 - This was a robust introduction to the candidates and the full event went smoothly. Candidates enjoyed and were appreciative of the opportunity
- Advocacy efforts by SEUL and NA members had a significant impact on the City's offering of additional budget to each of the District Coalitions.
 - SEUL's base funding was originally cut by 31% and the City's additional funds increase our base budget by \$25,000
 - The City also took responsibility for payment of District Coalition insurance
 - SEUL will submit an invoice to the City for this item to be reimbursed
 - Since the city pays this fee, it will not show in the SEUL FY 24-25 budget reviewed later in this Board meeting

7:20 Advocacy Request from Land Use + Transp. Committee: Reaffirm Support for Making Powell Blvd. Crossing Safe for All at 70s Greenway

Matcha Williams, SEUL Neighborhood Planning and Liaison Manager

- Land Use and Transportation Committee discusses a variety of topics impacting South East land use and transportation development through an equity lens and often issues recommendations to the Board in support or disapproval of various measures or development plans that fall within the district or impact the City at large.
- Land Use and Transportation Committee hosted a presentation of TriMet's plan for Powell Blvd Crossing at 70s Greenway in their May Committee Meeting, and then Matchu requested the Executive Committee provide direction on support for the proposed design in May Executive Committee Meeting; the Executive Committee recommended the Board vote on whether to support this plan.
- TriMet is planning for improvements to a critical crossing at Powell and 82nd. The surrounding neighborhood has been advocating for improvement to the pedestrian and bike crossing experience at this location for more than a decade
 - There is a greenway that is a vital throughway that runs 6 miles and provides safety for pedestrians, etc. but lacks safe connection to the other side of Powell
 - This letter of support is requesting a safe crossing to include a user-activated flashing beacon and a marked crosswalk built without further delay and continue to pursue additional safety improvements that are needed as this is not a complete solution
- Powell has not yet been transferred from ODOT ownership to City of Portland ownership
- Recommendation to the Board: reaffirm SEUL's support for making the Powell Blvd Crossing safe for all at the 70s greenway.
 - Advocate for future upgrade options and
 - o build the features presented by TriMet rather than delay these upgrades.

Nanci summarized Civic Life's rejection

Updating Bylaw Geographic Area, Number of Directors <u>7:45</u>

Nanci Champlin, Executive Director; Kat West, Vice President

- We need to update our bylaws so that starting July 1 they reflect our new district geographic boundaries and the Neighborhood Associations that can have a seat on our board.
- This is a result of the City deciding to align the four new City Council districts with the four nonprofit District Coalition Offices, including SE Uplift.
- In late April, the board received notice of these proposed bylaws changes and we discussed them at the May board meeting.
- We also discussed that there are four Neighborhood Associations (Ardenwald-Johnson Creek, Eastmoreland, Reed and Sellwood-Moreland) who have long been part of our coalition and were seeking to remain with SE Uplift as their District Coalition provider instead of getting their services from District 4, which encompasses all of Portland on the West side of the Willamette River, following the process outlined in the ONI Standards. The Bureau of Civic Life denied their request.



PROPOSED BYLAWS UPDATE #2

ARTICLE V. SECTION I. NUMBER OF DIRECTORS

Directors are selected by the neighborhood associations affiliated with the SE Uplift Neighborhood Program, and by community members who reside in, own real property, own a business in, or represent a nonprofit, business, or public agency within the defined area described in Article III. The number of Directors shall not be less than fifteen (15) or more than thirty-five (35) and shall be selected from individuals according to the following:

- No more than one (1) Director from each SE Uplift neighborhood association, except as these bylaws provide otherwise.
- Up to two (2) Directors from SE Uplift area business associations.
- C. Up to seven (7) Directors from SE Uplift area organizations, other than neighborhood associations, such as nonprofits, businesses or public agencies.
- Up to seven (7) Directors at large, who have special expertise, skills or interests deemed valuable to SE Uplift by the Board of Directors, or who bring a valuable diversity of backgrounds and lived experience to the Board of Directors.

SEUL's reserves are a significant strength, and the Unrestricted Net Assets is the bucket from which SEUL will be pulling money to make up the balance of City-approved budget and SEUL's proposed FY 24-25 budget.
- Discuss ExCom Recommendation to Extend Directors & Officers Insurance to Eligible Community Based Organizations Represented on the Board (Nanci)

8:11 FY 24-25 Organizational Budget

- The budget was drafted by Nanci in consultation with SEUL bookkeeper, and has since received input from the staff, Executive Committee, and Finance Committee.
- Nanci indicated that the Fiscal Sponsorship Fee changes now better reflect actual administrative costs. These changes were updated by the Executive Committee and communicated to the Board via email with more thorough explanation of the Executive Committee meeting discussion on the topic.
- Staffing cuts were made to meet new budget
- Budget reflects 19 neighborhoods and up to 4 Community Business Organizations as part of SEUL
- SEUL is going to provide \$200 out-of-pocket for Directors and Officers Insurance coverage for CBO's that serve on the board.
- Nanci walked everyone through each section
