- Executive Committee no report; did not meet last month
- IDEA Daniel Portis Cathers, Mt. Scott-Arleta NA
  - Workshop postponed until February
  - Interest in antiracism training is waning but still very important
- Climate Justice Action Committee, Nanci Champlin, Executive Director
  - Co Hosted forum with 350PDX
  - 6 candidates attended
- Houselessness Action Committee, Nanci Champlin, Executive Director
  - Forum this Friday
  - Three rounds of candidates all asked and answering all of the questions
- Land Use + Transportation Nanci Champlin, Executive Director
  - The Land Use & Transportation Committee at SE Uplift and representatives from the Interstate Bridge Replacement (I5BR) Program team have been invited to discuss the project including the new, modern bridge between Oregon and Washington.
  - The Draft Supplemental Environmental Impact Statement (SEIS) is available for review and comment through November 18th.
  - The public comment period required by the NEPA (National Environmental Policy Act) federal act is open and this is the last opportunity to provide feedback before the Final SEIS and Record of Decision are published next year.
  - Neighborhoods and anyone interested in sharing concerns or hopes about the project can attend to learn more.
  - The meeting includes a presentation from the ISBR team with time for questions, followed by a testimony writing workshop with materials from our partners at the Just Crossing Alliance.
  - Not sure where to begin or intimidated by testimony? This workshop is for you and will help build your capacity to provide input.
  - The meeting will be held online via Zoom. Information will be published to the Land Use & Transportation Bulletin and on the committee website (<u>seuplift.org/land-use</u>) Discover & Create Your Neighborhood at the SE Uplift Land Use & Transportation Committee.

    - As per the policy, it must be updated every three years, and we are at this point.
    - Remove the definitions section in the beginning.
    - Financial Policy will be addressed separately.
    - Streamline the policy by omitting redundant references to financial policy matters that are already covered in our Financial Policy.
    - Remove the "Background" section as this context is now very outdated.
    - Lower the amount of the Building Reserves to \$50k to reflect significant recent investments in the Main Street headquarters.
