Presenter: Marissa Cade (PREGAME, Coordinator)

Purpose of Portland Engagement Project (PEP) is to better engage individuals who are collectively under-heard. PREGAME is currently gathering feedback from organizations and individuals in Portland and create a framework for more equitable community-engagement model for the City of Portland.

#### Discussion:

- Community Alliance of Tenant (CAT) is intended to represent renters
- PREGAME begins "listening" phase on February 24th and is only contracted to "listen" this year

  - Newsletters that take paid advertisements: NA's and the Examiner, Oregonian,

  - Provide surveys directly to organizations that serve marginalized citizens
    - Identify those demographics that is underrepresented and those organizations that represent them
  - Next door advertising reaches various groups
  - Colleges, Universities and Grade Schools
  - Community Centers
  - o Civic Institutions: Rotary, Civic Clubs, Lions Club
  - QR code at local grocery stores
  - Chambers of commerce
  - Places of worship
  - Direct mailer to all residents
