 - O June 11 is the next time Council meets. Council considering 2 amendments that would restore what is posed to be cut from DCO's: funding cut in Mayor's budget, Community Small Grant Program
 - O Council President Package: a list of amendments to the budget that are low-hanging fruit for discussion.
 - o If Amendment fails or passes, insurance is still not considered
 - If budget does not pass there will be one more chance to amend and review
 - Grants to district coalitions are one year terms

- April 2025 Balance Sheet
 - o \$10k Contract to provide services to Urban Forestry: participating to register 8 priority neighborhoods for the tree giveaway
 - Office of Civic Life Grant considers the City Budget allowing district officers to pay for tenancy in the SEUL space
 - Personnel reduction reflects staffing reduction. If Community Small Grants program remains in the City Budget, there will be increased hours for the staff personnel handling these grants. This is reflected in Option 2 Budget
 - SEUL is required to provide NAs with insurance, but not directors and officers. SEUL budgets insurance for D&O because it believes in the value of providing this for this type of staff.
