7:19 Executive Director Updates – Nanci Champlin, Executive Director

- We finally received our **amended grant agreement f**rom the City and will review it this week.
- Please check mailboxes while in the building. Secretary of State renewals for NA groups are in.

- Will hear back from the Portland Clean Energy Fund (PCEF) on Nov 19 if SE Uplift will receive a
 grant to replace our windows, and install electric heat pumps upstairs, solar panels, and a solar
 hot water heater.
- The fireside room now has a **gallery wall** with an installation from Welcoming Week. Current pieces will be up through December. New art will be solicited to replace the current installation.
- All offices in the SE Uplift building are now rented. The newest tenant is Talk a Mile, which is an
 organization focused on pairing rookie police officers with Black youth to walk a mile together to
 get to know each other.

Past events:

- Welcoming Week We hosted about 25 guests for this event led by the City's Immigrant and Refugee Program which debuted the gallery and coincided with the farmers market in the outdoor plaza.
- The recording for Welcome to the Neighborhood (Association) training for new NA board members is available on the YouTube channel. All districts were invited to attend.
 We had about 22 participants and many more registered and received the recording.
